## 2021 CANADA EAST KART SPORT Membership

All entrants participating at CANADA EAST KART SPORT events as part of the East Coast Championship challenge and/or the Maritime Karting Championship must be a member of CANADA EAST KART SPORT. AMKA – Halifax club members are exempt, as their valid 2021 membership is welcome, as ours is at their events. Note to be eligible for season championship an annual membership at CANADA EAST KART SPORT is required.

CANADA EAST KART SPORT offers 3 membership fee options: Annual Membership Deadline Date: March 31<sup>st</sup> 2021, cost of membership will be \$175.00 after that date. Canada East Kart Sport will hold previous year race number until March 31<sup>st</sup> 2021 after that date the number will be released.

1. Annual membership \$ 125.00 (Before March 31<sup>st</sup> 2021)
2. 5 Race membership \$ 100.00
3. Single day memberships \$ 50.00 (put in place for potential new members)

Options 2 and 3 are subject to confirmation at time of application.

Race day fees for 2021 are on a race by race basis – see the web site and/or Race day Pre-registration/pre tech form for details.

2. ASN 2019 Karting Medical Self-Declaration for a Competition Licence.
3. ASN 2019 Annual Parental Consent waiver.(Not required if driver is 19 years of age or older)
4. Zero Tolerance Policy form, signed by driver & team members expected to attend events.

### **CANADA EAST KART SPORT Zero Tolerance Policy for Physical and Verbal Abuse –FORM # 3**

The mission of the Canada East Kart Sport is to provide a safe, fair, positive and respectful environment where all drivers, family members and team members, officials and spectators can enjoy the sport of Kart Racing.

The racetrack area must be free of negative factors, such as abuse, discrimination, intimidation, hateful words and deeds, and physical violence in any form.

The CANADA EAST KART SPORT will not tolerate:

- Bullying
- Cyber Bullying (Internet Related)
- Violence of any kind
- Harmful, threatening or actual acts of violence
- Verbal abuse of any form
- Any activity which places the safety of drivers, officials or spectators at risk of personal injury

The CANADA EAST KART SPORT Executive will ensure that:

- All members of the CANADA EAST KART SPORT receive a copy of the “Zero Tolerance Policy”
- Officials respond appropriately, without delay and in a consistent fashion when dealing with an incident
- There are serious consequences for any individual who is in violation with this policy, including, but not limited to:
  - **Disqualification** for a **heat** resulting in **zero points** for the **heat**
  - **Disqualification** for the **race day** resulting in a **DQ**, which cannot be dropped from seasons points, for the **race day**
  - **Suspension** from the **next race day**
  - **Expulsion** from the **CANADA EAST KART SPORT** for the remainder of the **season**
- Repeat offenders will be dealt with more severely and violation of this policy may result in permanent expulsion from the CANADA EAST KART SPORT, and/or Atlantic Region Motorsports.

The purpose of this policy is to:

- Reduce the incidents of verbal and physical abuse
- Provide opportunities for officials to develop the skills necessary to handle incidents of verbal and physical abuse in a consistent manner
- Promote long-term prevention of verbal and physical abuse, and violence by preparing individuals to manage themselves in non-abusive way

CANADA EAST KART SPORT began this policy in 2006. As a member, official or individual associated with the CANADA EAST KART SPORT we expect you to do your part and set the example by complying with this policy.

1. I am the parent/guardian having full legal responsibility for decisions regarding my minor child/ward,

I am familiar with and accept, on behalf of myself and my minor child/ward, that there is the risk of serious injury and death in participation, whether as a competitor, student, official or worker, in all forms of motor sport and in particular in being allowed to enter, for any reason, any restricted area; and
3. I have satisfied myself and believe that my minor child/ward is physically, emotionally and mentally able to participate in this **EVENT**, and that his/her protective clothing, gear and equipment is fit and appropriate for his/her use in this **EVENT**; and
4. I understand, and will instruct my minor child/ward, that regardless of his/her role, all applicable rules for participation must be followed and that at all times the sole responsibility for personal safety remains with my minor child/ward; and
5. I will immediately remove my minor child/ward from participation, and notify the nearest official, if at any time I sense or observe any unusual hazard or unsafe condition or if I feel that my minor child/ward has experienced any deterioration in his/her physical, emotional or mental fitness, or that of his/her protective clothing, gear or equipment, for continued safe participation in the **EVENT**.

A FULL AND FINAL RELEASE AND WAIVER OF LIABILITY AND ALL CLAIMS that I have or may in the future have against any person(s), entities, or organization(s) associated in any way with the **EVENT** including the track owners and lessees, promoters, sanctioning bodies, racing associations, or any subdivision thereof, track operators, sponsors, advertisers, vehicle owners and other participants, rescue personnel, event inspectors, underwriters, consultants, and others who give recommendations, directions or instructions, or engage in risk evaluation and loss control activities, regarding the **EVENT** or event premises, or any one or more of them, and their respective directors, officers, employees, contractors, agents and representatives (all of whom are collectively referred to as "the Releasees") from any and all liability for any loss, damage, injury or expense that my minor child/ward may suffer, or that his/her next of kin may suffer as a result of his/her use of or presence at the event facilities or my child's/ward's participation in any part of, or presence at, the **EVENT**, due to any cause whatsoever, INCLUDING NEGLIGENCE, GROSS NEGLIGENCE, BREACH OF CONTRACT, OR BREACH OF ANY STATUTORY OR OTHER
